GALLERY

Katie and Aaron Burkland (1312 Sunrise Lane) reported that she and her dog were attacked by 2 pit bull/mastiff dogs while walking in the street outside of a home in Byron Woods. Her dog was severely injured, and she was bitten. The dogs ran out of the front door and the attack took place. This is the second time these dogs have attacked. She is asking the Village to create some ordinances in order to prevent this from occurring again and that the Village ensures that the owners are held accountable in the future.

Trustee Lindley is going to look into creating an ordinance that requires dogs to go through a training class after an attack takes place, as well as looking into updating the current ordinances on vicious animals.

Clerk Engels presented the new Development Agreement from Attorney Kathy Orr. The new Development agreement presents the \$12,500 initial upfront payment upon completing an inspection which is specified in the contract.

Trustee Oney and Trustee Lindley asked if there was a clause in the agreement that would discontinue payments in case they went out of business.

Clerk Engels reported that Attorney Orr specified that we would not be responsible for any future payments to the owner or the new owner. There is also a clause in the contract that states that the business can not be sold without the consent of the Village.

Mayor Bruce Peterson declared motion passed

Mayor Peterson reported that the property located at 305 N High Street is up for online auction from August 3rd-5th. He wanted to see if there was any interest in the Village purchasing the property and tearing it down to eventually sell to an interested party. Inspector Doug Streeter told Peterson that it would take approx. \$15,000 in expenses to remove the house, filling it in and preparing it for commercial sale.

Attorney Gorham understands that there was a Sherriff sale of the property and that the bank bought it back. It will be listed on auction.com for online sale. After a certain period, it will be signed an MLS # and it will be put up for sale through a realtor if it does not sell during the online auction.

Trustee Sloan said that the costs associated would not be worth it to the Village even if we obtained the property for free. He said that in his experience, foreclosed properties normally have hidden liens that the banks will not clear. A title search would have to be completed.

Trustee Lindley said that she believed the Village decided after the Old Academy purchase, that the Trustees decided that the Village is not in the real-estate market.

Mayor Peterson expressed that this property is harming the Village and the adjacent property owners. He believes that this warrants the Village to consider the purchase.

Trustee Bitler asked if there was a way for us to create an ordinance to make the owner maintain the property or condemn the property if it is not tended too.

Attorney Gorham reported the she would have to look into the Village's ordinances.

Trustee Lindley reported that the Village does have an ordinance pertaining to unsafe buildings.

Attorney Gorham will be in contact with the realtors and get updates on the property as it becomes available.

Trustee Lindley reported that the August Economic Development meeting for August will be cancelled due to flooding at Village Hall. They expect their next meeting to be held in September.

Trustee Meade reported that the August 12th meeting will be held. The P&Z committee have projects that are starting to pile up since there has been no meeting since March. They are hoping to dive into the comprehensive plan.

Trustee Lindley reported that she has been working with Trustee Oney on a water department ordinance.
